#### **About this book**




The Independent Advisory Council to the NDIS wrote this book.

The National Disability Insurance Agency or NDIA manages the **National Disability Insurance Scheme**.




The National Disability Insurance Scheme or NDIS gives services and support to people with disability.

- ask for our feedback.



• a welcome to new Council member Dr Leighton Jay




work Ms Leah van Poppel is doing as the new
 Deputy Chair of the Council




- work being done to

The NDIA spoke about **Independent Assessments**.




Independent Assessments is the new way the NDIA will work out

• how your disability affects your life



and

what supports you need from the NDIS.



The assessments are independent because they are done by someone who

• does **not** already know you



and

• is **not** the healthcare professional you usually see.




The NDIA will

• talk to people with disability

and



 do more work to make the Independent Assessments happen.

- Local Area Coordinators




• community connectors.



The Council wants the NDIA to make all information about Independent Assessments accessible.

### **Participant Satisfaction Survey**



The NDIA spoke about work being done to make the Participant Satisfaction Survey better.



Participant Satisfaction Survey means NDIS participants give **feedback** on services they get from the NDIS. We will call it the survey.



Feedback means you tell someone what you think.



The NDIA told the Council that

more participants can now be part of the survey





 more participants in the survey means the NDIA can make services better.



The survey is being tested for accessibility and the Council will help with this work.

The National Disability Strategy Outcomes Framework is for government to

understand how well some things work for people with disability



and

• use the information to help people with disability reach their goals.



The Council will tell government what goals to measure so the outcomes frameworks work well.

For example



access to education

and



employment opportunities.



The Council said that the National Disability
Strategy needs to have clear information about

• justice and the law


and




• child protection systems.

The Department of Social Services or DSS spoke to the Council about the Information Linkages and Capacity Building program.




The Information Linkages and Capacity Building program or ILC program gives money to community programs to help make sure people with disability

are connected and included in the community



and

• can reach their goals.



The ILC program is now managed by the DSS instead of the NDIA.



### The Council told the DSS that

 the ILC program needs more money to do everything it needs to do

and



- more money should go to
  - groups who employ people with disability

and



projects for young children.

### **Early Childhood Early Intervention**



The Council was asked to give feedback on the Early Childhood Early Intervention Implementation Reset Project.



Early Childhood Early Intervention is how the NDIS helps children under the age of 7 years.



The Implementation Reset Project is a review of how the NDIA supports early childhood and

what works well





what can work better.



The Council is working with the NDIA to make early childhood supports better.
